1. Declaration of compliance to Regulation 10/2011/EC (Food Contact)

The hot stamping foil is formulated in accordance to the EUPiA Guidline on Printing Inks applied to the non-food contact surface of food packaging materials and articals.

2. Declaration REACH

Hot stamping foils are articles and do not require registration.

3. Declaration of compliance to SVHC List

we confirm that for the formulation of the products we deliver to you no substances are used which are listed in the extended ECHA candidate list of Substances of Very High Concern (SVHC) from 01/15/2019

4. Declaration of presence/absence of animal origin substances (BSE/TSE)

The raw materials for the hot stamping foil do not contain substances of animal origin.

5. Declaration of compliance to RoHS III refers to DIRECTIVE 2011/65/EU

We confirm that for the formulation of the products we deliver to you do not contain substances are in the regulation **Directive 2011/65/EU**. That means no substances are used which intentionally contain lead (Pb), Cadmium (Cd), hexavalent Chromium, (Cr(VI)), polybrominated Biphenyl (BPP) or polybrominated Diphenylether.

6. Declaration of presence/absence PCB (polychlorobiphenyl)

The formula of the hot stamping foil does not contain PCB.

7. Declaration of presence/absence BPA

Bisphenole A is not used for the formulation of the hot stamping foil.

8. Declaration of presence/absence GMO

No GMOs are used for the formulation of the hot stamping foil.

9. Declaration of presence/absence of Asbestos

No Asbestos containing substances are used for the formulation of the hot stamping foil.

10. Declaration of presence/absence of Nickel

No Nickel no Ni-derivates are used for the formulation of the hot stamping foil.

11. Declaration of presence/absence PVP (polyvinylpyrrolidone)

No PVP is used for the formulation of the hot stamping foil.

12. Declaration of latex

The formula of the hot stamping foil does not contain latex.
